A derivative is a financial instrument or other contract that derives its value from the changes in value of some other underlying asset or other instrument.

Characteristics:

- 1. its value changes in response to the change in an underlying;
- requires no initial net investment or a very minimal initial net investment; and
- 3. it is settled at a future date.

- 4. To speculate (incur risk); or
- 5. To hedge (avoid or manage risk).
