A derivative is a financial instrument or other contract that derives its value from the changes in value of some other underlying asset or other instrument.

Characteristics:

1. its **value changes** in response to the change in an **underlying**;
2. requires **no initial net investment** or a very minimal initial net investment; and
3. it is settled at a **future date**.

Purpose:

4. To speculate (incur risk); or
5. To hedge (avoid or manage risk).
